

Declaration of consent for Data processing for specific purposes

Copy Veterinary Practice

In some cases, it may be necessary for Zentrum für Tierzahnheilkunde – Die Tierarztpraxis to pass on your personal data as part of veterinary referrals or return referrals to other veterinary practices, veterinary clinics and as part of further diagnostics for testing laboratories and institutes.

The data collected can be transmitted to other veterinary practices or clinics, laboratories, institutes, and pharmacies, etc. for diagnostic and therapeutic purposes.
- ☐ I consent to Zentrum für Tierzahnheilkunde – Die Tierarztpraxis processing my contact details as well as the necessary data relating to my animal in order to remind me of upcoming vaccinations and, where applicable, other veterinary preventive care or check-up appointments. Contact may be made by telephone, email, SMS, or by post.
- ☐ I agree that Zentrum für Tierzahnheilkunde – Die Tierarztpraxis takes images of my animal as part of the treatment procedure and may use them for public advertising purposes in print and online (excluding the publication of personal data) as well as scientific evaluations and publications.
